

General Privacy Notice

Welcome to our General Privacy Notice. This is where we describe how we handle your personal data, which is information that is directly linked or can be linked to you. It applies to the personal data that Tong Lu (“we”, “us”, or “our”) as the data controller when you interact with this Phone Manager: Senior Care (“App” or “Service”). By using the App, you accept and agree to the terms of this Notice.

● Personal data we collect

The personal data we will collect about you includes:

- (1) IP addresses.
- (2) your name and email address.
- (3) activity Information directly related to your use of the App, includes contact list and or photos.
- (4) device information includes device types and settings, device identifiers (such as IDFA, IDFV for Android, GAID for IOS), browser types, mobile, wireless, operating system versions, another network information (such as internet service provider name, carrier name and signal strength), and application version numbers.
- (5) usage data includes the pages of our App you visit, the time and date of your visit, the time spent on those pages, unique device identifiers another diagnostic data.

● How we use the data

We may use your personal data in the following ways/for the following purposes:

- (1) To provide Service you request.
- (2) To provide user support and communicate with you about your questions.
- (3) To protect the security and integrity of the App, systems, servers and other technical assets.
- (4) To operate, evaluate, and improve our business.
- (5) To meet legal requirements, or as required by a judicial process or a government request, and to establish, exercise, or defend a legal claim.

- **Minor's data**

The App is not intended for individuals under the age of 13. We do not intentionally gather personal data from such individuals. If you become aware that a minor has provided us with personal data, please notify us.

- **How we share the data**

We may share personal data with the following recipients:

- (1) To our affiliates and subsidiaries as necessary to accomplish the purposes described above.
- (2) To third-parties that offer consulting, support, and technical services for our Service.
- (3) To vendors to provide part of Service on our behalf.
- (4) In response to valid legal process, including from law enforcement or other governmental agencies.
- (5) As we otherwise believe is necessary to protect our rights or property, including the security and integrity of the App.

- **Data security**

We take care to guard the security of your data. We use physical, technical and organizational measures that are reasonably designed to protect personal data against accidental or unlawful destruction, loss, or alteration; unauthorized disclosure or access; and against all other unlawful forms of processing.

- **Data retention**

We'll retain your personal data as long as you continue using of the App and as needed to fulfill contractual obligations, comply with legal requirements, resolve disputes, and enforce agreements. The retention duration depends on the purpose of data collection and any legal obligations.

- **Your privacy rights**

You may have specific legal rights regarding your personal data:

- (1) The right to access the data collected about you.
- (2) The right to receive your collected personal data in a structured, commonly used, and machine-readable format.

- (3) The right to rectify or update inaccurate or incomplete personal data under certain circumstances.
- (4) The right to erase your personal data under specific conditions.
- (5) The right to withdraw consent, where processing is based on your consent.
